Financial statements are to be filed
on the following dates:

February 14, 2011 Monday	First filing of campaign receipts and expenditures
March 4, 2011 Friday	Second filing of campaign receipts and expenditures
April 11, 2011 Monday	Third filing of campaign receipts and expenditures

Only for villages with less than 10,000 population: Candidates and their committees raising or expending more than \$1,000 are required to file financial statements pursuant to 6200.2 of the New York State Election Law.
